


# ISC - Alberta Region COVID-19 Daily Update for Chiefs: April 17, 2020



## Updates

### First Nations Elections:

On April 7, 2020 the First Nations Election Cancellation and Postponement Regulations (Prevention of Diseases) came into force. The regulations allow for *Indian Act* band councils to delay *Indian Act* and *First Nations Election Act* elections for up to 6 months and extend the terms of incumbent chiefs and councillors due to the COVID-19 pandemic. The regulations provide guidance that chiefs and councillors “chosen according to custom . . . may” have their terms extended, “even if the custom does not provide for such a situation.” Certain restrictions do apply. ### Confirmed Case Process:

The FNIHB Medical Officer of Health (MOH) is informed by the provincial lab of any positive test results for individuals with a First Nation listed as the place of residence. The individual will be notified of the test result by the local public health nursing team and direction will be given to self-isolate.

The FNIHB CDC team will contact the Nation's community health nursing team. The FNIHB CDC team will review case management and contact tracing requirements with the community health nurse (CHN). The Nation's CHN will follow-up directly with the client to review isolation requirements and collect the relevant information to initiate public health follow-up measures. Appropriate isolation and testing for close contacts of the COVID 19 positive individual will occur to ensure public health measures are in place to mitigate the spread of COVID-19 in the community.

## Question of the Day

**Q: What steps are being taken to ensure health care workers don't bring COVID-19 to my Nation?**

**A: On March 16, 2020, ISC released directives on the self-screening of health care professionals for COVID-19 symptoms to limit the spread of the virus to others in the community. On April 15, 2020, healthcare workers have also been directed to utilize masks continuously in healthcare settings to ensure they are not spreading COVID-19.**

Other measures that have been taken by Indigenous Services Canada, Alberta Region to ensure health professionals are not at-risk of exposing communities to COVID-19 include training sessions on the proper use of PPE, with additional resources available through onehealth; a weekly bulletin to First Nations in Alberta, distributed to nursing staff; weekly telehealth sessions for all First Nations in Alberta that include updates on COVID-19 and self-isolation requirements; and sharing of all relevant and updated resources related to public health requirements, screening and self-isolation guidelines from AHS, PHAC and the WHO. As well as using tools such as Health Care Workers Self-Assessment and formal risk assessments when doing home visits.
